
In June 2017, our Director and Co-Founder, **Kate Birch**, stepped down as director. In June we welcomed **Ursula Dobelmann** for Social Media and **Mary Baenen** for Editing and Documents and in September **Adelle Hansen** as the Ethics/Legal representative. In January 2018, **Marci Mearns** will take up the board position dedicated to tech and web development. **Kim Lane** has stepped out of active board duties at the end of the year but remains as Medical Advisor to the research. Adding these new board positions allows for FHCi to operate under a "collaborative governance" rather than a directorship model (see Goals for 2018).

**We have one 'at large' board position remaining to be filled for 2018.** We are looking for a motivated person with gifts and talents to offer FHCi with regards to finance, leadership, social media or marketing.

**Kate Birch** remains the International Development Coordinator and will be concluding the research of the effectiveness of the HP program. During the winter of 2018, focus is on collection of data and status of program participants. Analysis will take place over the summer months and made public by fall of 2018.

## Goals for 2018

We have restructured the board for a total of twelve positions each with three years of service moving through three tiers of service. There are four board members at each level of service. Between the levels of service there is a buddy system established for communication, mentorship and monitoring of work to ensure all activities of the board come to fruition.

- **Year one:** Apprentice: Learning what the board does and becoming acquainted with the tasks of the individuals chosen position.
- **Year two:** Advocate: The portfolio of the board member is well established and attention is set to initiate and complete directives of that portfolio in collaboration with related board positions.
- **Year three:** Coordinator: Coordinate all activities such as: Chair Board meetings, oversee different branches of the governance structure needed to administer FHCi, and adhere to calendar of events throughout the year.

## Four main areas of focus for 2018:

- **First quarter:** Define new roles, responsibilities and relationships on the board of directors.
- **Second quarter:** Connect with HP Supervisors in the field, facilitate participation in local presentations on HP and encourage networking with families and communities.
- **Third quarter:** Develop avenues of communication between HP Families and FHCi so as to inform FHCi on ways to support these HP Family Members in communicating about HP with their families and the medical community.
- **Fourth quarter:** Conclude analysis of, summarize and publish FHCi HP research.
