2018 Annual Report

January 2019

FHCi restructured the Board in 2018, allowing it to operate under “collaborative governance,” rather than a directorship model. The FHCi Board has a total of twelve positions, each with three years of service:

Apprentice - 1st year, **Advocate** - 2nd year, and **Coordinator** - 3rd year. This rotating platform allows for participation in all aspects of leadership throughout one’s term.

Report from FHCi Board Members 2018

Mary Baenen: updated the FHCi booklets for US and UK, added HP for Streptococcal disease to the booklets, created a simpler HP booklet for additional children; and oversaw the creation of the annual report.

Alison Bell: maintained all accounts and fiscal duties, and chaired board meetings April through June.

Kimberley Bennett: participated in outreach to past and current Canadian HP supervisors to evaluate and problem solve limitation of access to HP in Canada. Kimberley resigned from the board during the year leaving a vacancy.

Kate Birch: relinquished oversight of board functions; developed board infrastructure with rotating chair schedules; trained board members for chairing board meetings; conducted budget analysis and review; and simplified various tech platforms and document review coordination.

She participated in the Health Freedom Conference, introduced HP in the UK at the Alliance for Registered Homeopaths Annual Conference, facilitated the fall 2018 Strategic Planning Meeting; and continued to mentor HP supervisors through WhatsApp.

Amber Curie: organized a showing of Magic Pills for HP Awareness Week and two public HP lectures. She sent out a special end-of-year fundraising newsletter - the first of a recurring series and is working to streamline processes for FHCi.

Sarah Damlo managed the list of existing/new HP families; contributed to newsletters; updated the website; organized financials; engaged with board members and supervisors about membership; and compiled research data.

Collective Goals for 2019

FHCi held its second strategic planning meeting in November 2018. Goals from this meeting are as follows:

1. Streamline the management of board infrastructure, calendar of events, chairing responsibilities and internal buddy systems to keep us on task and improve outcomes.
2. Develop advanced HP education and a tech platform for HP Supervisors to effectively manage the needs of families from all backgrounds and health statuses. The focus will be on infectious disease management, immune system support, and vaccine injury recovery.
3. Develop a public education curriculum and platform to support families in finding the language to discuss homeoprophylaxis with their friends and families.
4. Conclude analysis of and publish the 10-year Homeoprophylaxis research results.
5. Development of an HP Supervision model that will build into it more client contact time to deepen family connections and greater adherence to the program.
6. Obtain international exposure and expansion to HP in Brazil, UK, India, and Turkey.
7. Increase social media presence during two important publicity weeks in April and August.

II. Four main areas of focus for 2019:

- **First quarter:** Complete the 10-year HP research with analysis and publication by June; send FHCi newsletters out monthly.
- **Second quarter:** Provide advanced HP education for existing HP supervisors; connect with HP supervisors in the field; facilitate participation in local presentations on HP; and encourage networking with families and communities.
- **Third quarter:** Develop a feedback system between HP Families and FHCi to elicit ways to support HP Family Members in communicating about HP with their families and the medical community.
- **Fourth quarter:** Hold strategic planning meeting for 2020 and draft 2019 annual report.
